GOVERNMENT REWATI RAMAN MISHRA PG COLLEGE, NAVAPARA, SURAJPUR, CHHATTISGARH INDIA

Terms: This agreement will become effective immediately after the date of signature by both parties. It shall remain valid for a period of three (3) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both parties. The agreement may be extended by written mutual consent of renewal by both parties after the mandatory period.
