## MEMORANDUM OF UNDERSTANDING

Govt. Rani Durgawati College (hereinafter called 'GRDC'), Wadrafnagar was established on July 11<sup>th</sup>, 1989 by the Department of Higher Education, Govt. of Madhya Pradesh and is presently run by the Department of Higher Education, Govt. of Chhattisgarh. GRDC is affiliated with Sant Gahira Guru University, Sarguja, Ambikapur. GRDC is a NAAC-accredited college and is one of the reputed colleges in the Sarguja Division, where students up to 40 km away regularly attend classes. Most of our college students belong to a tribal and

farming family. The purpose of the establishment of GRDC is to provide higher education to the students especially those who were socially and economically deprived as it is a tribal area. College is working with the vision; to make all-around development of the students by providing them quality and moral value-based education by which they are capable to face all the challenges and obstacles so that they may be useful members of society.

The Govt. Revati Raman Mishra PG College (hereinafter called 'GRRMC'), Surajpur was established in 1984-85. After seven years of its establishment, the Chief Minister Shri Sundarlal Patwa gifted the college its own building along with 26.5 acres of land on 17 September 1991. It is noteworthy that this college located in today's district headquarters Surajpur, which has the pride of being the largest tehsil in undivided Madhya Pradesh, has been given the status of the leading college of the district by the government. This college was initially affiliated to Guru Ghasidas University Bilaspur. The building of the college is located in Guru Ghasidas Ward of Surajpur. This college is registered under Section 2 (f) and 12 (b) of the University Grants Commission. The revised naming of the college has been kept in the name of former MLA Pt. Revati Raman Mishra. In the year 2016, it was awarded 'B' grade in the first cycle by the National Assessment and Accreditation Council (NAAC). In the year 2023, it has been awarded "B+" plus grade in the second cycle by the National Assessment and Accreditation Council (NAAC).

### **PURPOSE**

This MoU aims to cooperate and promote education and training in areas of mutual interest. Any other appropriate mode of interaction agreed upon between GRDC and GRRMC. This MoU will be helpful in the development of an eco-friendly environment through the collaboration of both parties and will be very helpful for local tribal people.

### **NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU, THE PARTIES HERETO AGREE AS FOLLOWS:**

#### **1. CO-OPERATION**

- 1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and cooperation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.
- 1.2 The cooperation between First Party and Second Party will facilitate the effective utilization of the intellectual capabilities and provide significant inputs to each other in developing suitable teaching/ training systems, keeping in mind the needs of both parties.

#### **2. SCOPE OF THE MoU**

- 2.1 Both parties believe that close cooperation between the two would be a major benefit to the student community to enhance their skills and knowledge.
- 2.2 Both parties will give valuable inputs to each other in teaching/ training methodology so that the students fit into the industrial scenario meaningfully.
- 2.3 The interaction between GRDC and GRRMC will give an insight into the latest developments /requirements of the present scenario; the Second Party to permit the Faculty and Students of the First Party to visit which will give them an opportunity to interact with the subject experts, research-scholar and learn interest-specific workings and wisdom from them, which will eventually lead the students to understand better subject skills, leadership skills, team player attitude, etc.
- 2.4 Both parties will train the students of each other on the latest technologies (which they have) to bridge the skill gap and prepare them for higher studies and research and extend the necessary support by delivering lectures/expert talks.



- 2.5 Both parties will be involved in enhancing entrepreneurial mindsets among the students by organizing various workshops/seminars and assisting the students in establishing various start-ups and generating self-employment opportunities through experts.
